1. Administration Plans

Members

2. Dark Skies Event - DA

Heriot- Watt University will provide financial assistance. They have already paid for inclusion within the Science Festival Programme and brochure.

The event can no longer be held on Good Friday due to staffing issues. SPB to cancel the Kirk Hall booking.

An event will be held in association with the Astronomical Society at the end of January 2025.

An multi activity event will be held at Archerfield Walled Garden on Friday 11th April in association with the Science Festival. Suggested ticket limitation of 300 in the morning and 300 in the afternoon with a nominal fee of £3.

The Dark Skies event will move to weekend of 18th/19th October to take the opportunity of new moon at the end of the half-term holiday.

3. Village Hall - DC

The village hall was closed c.35 years ago. It could provide storage for various groups. The DVA registered a right to buy for the community and ELC have valued the hall at £2,000. There will be costs associated with refurbishment of the hall and Platinum Properties will be making an inspection in January 2025 to assess the structural integrity of the reinforced concrete skeleton of the building.

4. Heritage Lighting - DC

£10,000 has been received in pledges towards the replacement of the headers along Main Road towards the western end of the village as part of the planned Phase 4 upgrading works. We are now awaiting a response from ELC's lighting engineer regarding the scope of the works that this funding could achieve.

5. Local Place Plan - DC

DC has rewritten the LPP using appropriate terminology and cross referencing to policy. Further public consultation is required for the revised plan regarding the proposals for different zonations. Version 3 will be presented at the meeting on 20th February 2025.

6. RSPB Birdwatch Event - DA

The RSPB's Big Garden Birdwatch involves a record of birds encountered in your garden over a single one hour period between 7 January and 14 February 2025. Proposal for as many residents as possible to submit their results to DA to undertake a local spatial analysis to inform the village. RS to check with HES regarding use of the castle grounds. Residents may off their garden up for those without outdoor space to contribute.

7. Archive

Some archive DVA documents are stored in ELC facility in Haddington. 1985-1995 paper documents are in a poor state of order.
